Moved by Deputy Mayor Keith West and seconded by Councillor Shaun Ward to adopt the minutes of the June 15, 2020 Special Council Meeting. Motion carried.

Conflict of Interest - N/A

Mr. Doug Tyler and Ms. Tiffany Primmer presented on behalf of Mr. Faroog Burney, the new owner of the St. Joseph's Catholic Church, an offer to Council to see what interest or ideas could be used for the historical building. Mr. Tyler commented, "When the church was closed, the Strategic Planning Committee offered at that time to include the building in the Revitalization Plan as one of the few historic buildings in the Village."

Mr. Burney would like to see the building renovated for a type of social gathering for seniors and young people to go and enjoy time together while at the same time learning new ideas from each other.

The Village Council received a letter of concern that young people have been driving their bikes into the river at the Marina. Council's top priority is safety within the Village. They hope with the installation of video surveillance, this will help reduce these types of incidents.
